## **Explanation of Court Order**

Exhibit 1 paragraphs 1-5, and Schedule "A". Paragraph 5 of Exhibit 1 provides for the removal of any and all additional web pages that reference, and or hyperlink to, the Defamatory Content and/or the Defamatory Postings. Dear sir / madam, I am one of 50 named plaintiffs in a civil action commenced before the Ontario Superior Court of Justice in Toronto, Canada (Clancy et al v Farid Action No. CV-[REDACTED]6). I have previously submitted a de-indexing request to Microsoft. To date, that request has not been fully implemented. I write to request again the de-indexing of search engine results. The action arises out of a long-term campaign of cyber-bullying, harassment and defamation published by the defendant, a resident of Toronto, Canada, on numerous URLs hosted in the United States. On December 11, 2017 and on March 5, 2018, the Ontario Superior Court of Justice issued orders requiring the removal of the URLs from the Internet (the "Removal Order" ...
